

**AGREEMENT FOR ELECTRIC SERVICE AND MEMBERSHIP
WITH
LANE-SCOTT ELECTRIC COOPERATIVE, INC.

The undersigned (hereinafter "Customer") hereby makes application to the Lane-Scott Electric Cooperative, Inc. (hereinafter "Cooperative") for electric service and membership upon the following terms and conditions.

1. **MEMBERSHIP** – This agreement shall constitute written application for membership in The Lane-Scott Electric Cooperative, Inc.
2. **PAYMENT** – The Customer will, when electric energy becomes available, purchase from the Cooperative all central station electric power and energy used on the premises described below, and will pay therefore monthly at rates and terms which are filled and approved by the Cooperative Board of Trustees.

For the purpose of this agreement, the Customer will pay the Cooperative for service at rates and upon the terms and conditions set forth in **Rate Schedule** _____ until changed or modified by the Cooperative Board of Trustees.

The Customer hereby gives written consent to the Cooperative, to transfer to the customer's current service account, regardless of class, any unpaid balance owed for service received or costs incurred at this or any separate meeting point, residence of location, regardless of the class of service received or when such service was received whether prior, concurrent or successive.

3. **WIRING** – The Customer will cause his premises to be wired in conformation with the National Electrical Code and all applicable City and County Specifications. **All new motor loads of 30 horsepower or greater on single phase line, 40 horsepower or greater on V phase line, and 50 horsepower or greater on three phase line connecting to Lane-Scott's system shall be connected with Variable Speed Drives. If the connection of a load exceeds the Total Harmonic Distortion for current or voltage THDv or THDi in excess of IEEE 519 limits at the point of common coupling, then the consumer shall be responsible for the costs of reducing either THDv or THDi below said limit.**
4. **ADDITIONAL PROVISIONS** – The Customer will, as a member of the Cooperative, comply with and be bound by, as though fully set out herein, the provisions of the Certificate of Incorporation and Bylaws of the Cooperative, and any Rules and Regulations and Rate Schedules as may, from time to time, be adopted by the Cooperative Board of Trustees.
5. **DELIVERY OF SERVICE** – Service to be furnished under this agreement is to be delivered and received at a mutually agreed point on the Customer's premises located in **Section** _____, **Township** _____, **Range** _____, in _____ **County**. The Cooperative's meter shall constitute the point of delivery to the Customer and the Customer will own and maintain all poles, wires, equipment and other facilities beyond the point of delivery.
6. **PERSONAL LIABILITY** – The Customer, by signing the agreement and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law his private property cannot be attached for any such debts of liabilities.
7. **SECURITY DEPOSIT** – The Cooperative may require the Customer to provide credit information prior to rendering electric service. The Cooperative may also require at any time, upon proper notice, a cash security deposit in accordance with the Cooperative's Rules and Regulations. Such deposit will bear interest and be refunded in accordance with those Rules and Regulations.
8. **ACCESS** – The Cooperative will have the right of access to the Customer's premises for the purpose of installing, reading, inspecting or repairing any meters, devices, and other equipment or for any purpose incidental to the electric service supplied by the Cooperative.
9. **TERM** – The acceptance of the application by the Cooperative shall constitute a binding agreement between the Customer and the Cooperative and the contract for electric service shall continue in force from the date service is made available hereunder to the Customer, and thereafter until the later of 0 years or the date canceled by at least seven (7) days written notice given by the Customer to the Cooperative, or by disconnection of the Customer's service by the Cooperative.

- 10. **SUCCESSION** – This Agreement may be assigned by the Customer only with the consent of the Cooperative, but shall be binding upon and inure to the benefit of the Successors, legal representatives, heirs, devisees, and assigns of the respective parties hereto.
- 11. **WAIVER** – No representative, agent, or employee of the Cooperative shall have the power to amend, modify, alter, or waive any of the provisions or terms of this contract or any of the general terms and conditions relating not herein contained. Any promises, agreements, or representations made by any representative, agent or employee of the Cooperative not herein set forth shall be void and of no effect.
- 12. **COMPLIANCE** – Failure on the part of the Customer to accept service from the Cooperative, to comply with the Certificate of Incorporation, Bylaws, Rules and Regulations, or to carry out the terms and conditions of this contract, shall not relieve the Customer from the payments and conditions set forth in the contract.
