Tips for After Hours Outage Calls

As our members, you are our number one priority, and Lane-Scott is committed to providing you with the best service possible.

We encourage you to call whenever you have an outage, even if you think someone may have already called in, as this helps us isolate the problem.

Lane-Scott Electric employees are available to take your outage calls be-

tween the hours of 8 a.m. and 5 p.m. Monday through Friday.

An after-hours dispatch service is available for outage calls outside of our business hours.

Please note that when calling after-hours, the dispatchers are not employees of Lane-Scott Electric and may not be familiar with all of our members and territory.

How to Report an Outage

Please call 620-397-5327 or 800-407-2217 and provide the following information to the dispatcher:

- ▶ Your name and a phone number you can be reached at DURING the outage.
- ▶ Your address of and/or driving directions to the
- ▶ The name the electric account is in, if different from the name of the caller.

Please do not call 911 or the sheriff's department if the phone is busy. Simply wait a few minutes and try your call again.

> to respond in the most timely manner possible, we ask that you provide our dispatch service with the information listed above when calling. We suggest that you clip out the information above and keep for a reference to use during outages.

We serve all or part of eight counties, so the more detailed information you give us the better our linemen can respond.

Lane-Scott Linemen Prepare for the Kansas State Fair

Lane-Scott along with 31 other Kansas electric cooperatives and Touchstone Energy Cooperatives of Kansas are cosponsoring a high-voltage line safety demonstration in combination with the Kansas State Fair, September 10-14. Cooperative linemen from Lane-Scott Electric and five other cooperatives have volunteered to help spread the message.

Teaching the public to stay safe around power lines is the focus of the electric cooperatives' message at this year's fair. The demonstration, which is part of "Kansas' Largest Classroom," is a half-hour in length and will incorporate a full-size electric safety demonstration, which is on loan from

Midwest Energy.

Journeymen linemen will demonstrate proper safety precautions and teach viewers what protective gear linemen use and why, what happens to a person when they come into contact with an energized line and why birds can land safely on power lines.

The public demonstration will operate from 9 a.m. to 1 p.m. and is free of charge for all fair attendees. The demonstration will be located in the Beef Judging building, east of the Oz Gallery.

"Kansas' Largest Classroom" provides teachers with materials like lesson plans and lists of activities to assist with their trip to the Kansas State Fair.


